In order for this health guarantee to be valid, the following conditions must be met:</p> <ol style="list-style-type: none"><li>1) All pups are of sound mind and body and are stable temperment upon purchase of pup. Bravo Kennel is not responsible for the temperment of any pup after it leaves the premises.</li><li>2) All puppies must carry the (Bravo's) name on their registration.</li><li>3) The dog must be registered with the FCI. And any future pups of said dogs thereof.</li><li>4) The dog must be x-rayed &amp; evaluated by the "Penn-Hip" or "OFA" method when the dog reaches two (2) years of age before breeding of any breed or show quality Bravo Kennel Dog. <b>(Pet quality Bravo Kennel Dogs shall never be bred.)</b></li><li>5) The dog remains current on all vaccinations and dewormings, including all puppy shots recommended by a licensed veterinarian. The next vaccinations and deworming are due:_____. This guarantee is non-transferable.</li><li>6) No dog shall be bred before passing "Penn-Hip" or "OFA" certification. No bitch shall be bred before her third heat cycle.</li><li>7) New owner will have pup professionally obedience trained.</li><li>8) The owner of this pup agrees to and gives Bravo Kennel permission to use and advertise any photos or documents in reference to this Bravo Kennel Pup.</li></ol> <p>The breeder must be presented with a certified letter from a licensed veterinarian within 30 days of finding any congenital hip dysplasia. The dog <u>must</u> be returned to the breeder with the registration papers for a replacement puppy. A replacement of equal value will then be given to the buyer, as soon as one becomes available.
